

## **Conflict of Interest in Assessment Policy**

#### Purpose

SCL International College is devoted to ensuring that the assessment and internal quality assurance process remains impartial. We are committed to preventing conflicts of interest that might compromise objective judgment or unduly advantage or disadvantage a student.

#### Scope

This policy applies to all individuals representing SCL International College. It is crucial that every staff member adheres to the Conflict of Interest in Assessment Policy. All personnel of the College must be aware of the potential for conflicts of interest.

#### **Definition of Conflict of Interest**

Conflict of interest arises when a tutor, assessor, or internal verifier faces conflicting interests or allegiances. For instance, a situation where a college representative has friends or family members undergoing assessments or exams could potentially, or seemingly, influence their decision-making.

#### **Key Points**

It falls upon each individual to identify and declare any circumstances that might cause a conflict of interest or situations that others might perceive as such.

In the event of a potential or actual conflict of interest, the affected individual should first bring the matter to the attention of the Academic Director of SCL International College. If necessary, a "Conflict of Interest in Assessment" form should be filled out (see appendix).

Before every assessment cycle, all staff and other relevant parties must notify the College about any students they know personally, be it family members, other relatives, or friends, who are being entered for examinations or other assessments.

### Definition

An 'Adverse Effect' is defined by Ofqual as:

"An act, omission, event, incident, or circumstance has an Adverse Effect if it -

(a) gives rise to prejudice to Learners or potential Learners, or

(b) adversely affects -

(i) the ability of the awarding organisation to undertake the development, delivery or award of qualifications in accordance with its Conditions of Recognition,

(ii) the standards of qualifications which the awarding organisation makes available or proposes to make available, or

(iii) public confidence in qualifications."
